Data & Process Improvement	Initiatives to streamline data collection, analysis, and reporting processes.	Summary report of findings and implementation.	Most organisations will initially have data gaps or low quality data. Those with limited internal resources may need help to improve this following the first assessment.
Emission Reduction Advice	Identifying opportunities and building the business case to transition to lower emissions.	Business cases to present to the Board and an emission reduction roadmap.	Organisations focused on a higher-level understanding of the financial implications of emission reduction opportunities and the forecast carbon reduction impact. Larger organisations who may be setting emission reduction targets or strong incentives to reduce emissions.
Supply Chain Engagement	Facilitate data requests to suppliers, supporting them through Sumday. Enhanced accuracy of emission assessments and training in GHG accounting and supply chain engagement to sustainability and procurement professionals.	Identify suppliers, send requests, monitor responses, and report.	Any organisation with a net zero or lower-emissions target. For large organisations already carbon accounting, this Scope 3 challenge is still a pain point, which we can support you with independent of your overall GHG accounting.
Materiality Assessment	Identifying the most relevant sustainability issues for the organisation and determining which metrics to include in the sustainability report.	Materiality matrix and recommended metrics.	Organisations aiming to align sustainability efforts with key stakeholders’ expectations and focus on impactful sustainability metrics for reporting purposes.
